


Performance since launch in %




Risk - Return Profile since launch annualized





Portfolio Manager's Report

In the first quarter, the integration of the projects "Campanario I" and "Neuss", which were acquired in December 2020, took place. In addition, the planning and implementation of the retrofitting of the needs-based "night identification" of all German wind turbines in the Fund's portfolio was advanced. This will ensure that these wind turbines can continue to be operated in compliance with the law after the end of 2022.

The first quarter was characterised by moderate wind levels, which led to lower revenues across the portfolio.

The fund closes its books in March, so this quarterly report also marks the end of the 2020/21 financial year.

In addition to the **PRI (Principles for Responsible Investments)**, we became a member of the two following important associations for ESG investments, politics and society:

SSF / Swiss Sustainable Finance

SSF / Swiss Sustainable Finance has set itself the goal of strengthening Switzerland's position as a leading centre for sustainable financial services. ESG financial investments are among the strict criteria imposed on SSF members. Another goal of the association is that more companies face up to their responsibility so that as many market participants as possible come closer step by step to the goal of a sustainable economy in Switzerland.
