





In September the annual dividend was paid to the shareholders, since 2009 without interruption. Together with the interim dividend for end of 2016, the dividend yield should again exceed 3% in total.

In August the wind farm Hambuch in Rhineland- Palatinate with a Nordex N117, 2.4 MW turbine and a total height of ca. 200m was purchased. The commissioning will be in the 1st quarter 2017.


Wind farm Bärweiler
